Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the recognition and measurement principles laid down in the applicable Indian Accounting Standards ('Ind AS') specified under Section 133 of the Companies Act, 2013 as amended, read with relevant rules issued thereunder and other recognised accounting practices and policies has not disclosed the information required to be disclosed in terms of the

Regulation, read with the Circular, including the manner in which it is to be disclosed, or that it contains any material misstatement.

We did not review the interim financial information of subsidiary, Free bird Aerospace Private Limited included in the consolidated unaudited financial results, whose interim financial information reflect total assets of Rs. 15.03 Lakhs as at June 30, 2021, total revenues of Rs. NIL for the quarter ended June 30, 2021, total net loss of Rs. 0.32 Lakhs for the quarter ended June 30, 2021, total comprehensive income of Rs. Nil for the quarter ended June 30, 2021.

These interim financial information have been reviewed by other auditors whose reports have been furnished to us by the Management and our conclusion on the Statement, in so far as it relates to the amounts and disclosures included in respect of these subsidiaries is based solely on the financial informations provided to us by management.

Our conclusion on the Statement is not modified in respect of our reliance on the interim financial information certified by the Management.
